## UNASDG CONVENTION «REPUBLIC OF XXXSTATEXXX»

RATIFIED

*The Parties to this Convention, hereinafter referred to as the Parties, agree as follows:*

*To promote the implementation of the 17 Sustainable Development Goals (SDGs) with 169 sub-goals, defined by the United Nations (UN) and adopted by 196 government members at the United Nations General Assembly in New York, USA on September 25, 2015 and by promoting the practical implementation of the UN Charter, the economic articles of the Final Act of the Helsinki Conference on Security and Cooperation in Europe (OSCE) in 1975, the Treaty of Lisbon from 13/12/2007 and earlier related Treaties, the provisions of the Vienna Convention on Diplomatic Relations of 18/04/1961 S., Vienna Convention on the Representation of States in their Relations with International Organizations of an International Character of 14/03/1975 and norms of international law in the framework of bilateral agreements, for ensuring a high level of cooperation and responsibility in matters related to the implementation of sustainable development goals, for the purposes of promoting the creation of networks and economic development programs, providing advice, recommendations, direct action and assistance in matters, related to the field of implementation of sustainable development and peace agreements, in particular through the contribution of an international technical committee and security body, as well as through the preparation, control and provision of international economic development investments in accordance with the regulations of international financial regulations, the UNSDG confirms its willingness and intention to start a long-term cooperation with the Republic of XXXStateXXX, hereinafter referred to as "State". Likewise, the Republic of XXXStateXXX agrees herewith to start a long-term cooperation with the UNASDG Intergovernmental Organization and accepts the Organization with signing the present Convention/Treaty as full sovereign body with full diplomatic immunity.*

*The objectives of the cooperation are the smooth implementation and completion of projects and processes at the technical, environmental, economic, humanitarian, and financial levels, within the framework of the 17 Sustainable*

*Development Goals with 169 sub-goals, especially following the AGENDA 2030, as well as the safeguarding of all stakeholders and involved structures, through the involvement of the UNASDG Security Council of the organization explicitly established for this purpose. UNASDG is ready, willing and able to introduce a 2 year Universal Basic Income (UBI) for every Citizen with up to US\$ 160/monthly.*

*It is also agreed to link the UNASDG Security Council all known and relevant national institutions of the State Party (Ministry of Interior, Ministry of Foreign Affairs, National Police, National Security, Financial Investigation Unit, Anti-Corruption Committee, etc.) and approves the installation of the Diplomatic Mission for SDGs in the Republic of XXXStateXXX.*

*The Republic of XXXStateXXX and/or the Ministry of Finance undertakes to designate the Central Bank of the Republic of XXXStateXXX as the depository in which UNASDG and its related structures may hold stocks of currencies or other assets and carry out monetary transactions for the funding of the Sustainable Development Goals (SDGs), Funding the UBI, recapitalization and monetization of international debt, within the jurisdiction to be specified in each case. For this purpose, the Central Bank of the Republic of XXXStateXXX shall open an account for the UNASDG Intergovernmental Organization.*

*UNASDG shall assume responsibility for the receipt and registration of accounts opened with the Central Bank of the Republic of XXXStateXXX for the clearing of such currencies from general ledger to general ledger or for electronic/digital transfers of all kinds and Currencies including API Link Transfer for digital USD in accordance with the required procedures for monetary compensation under the jurisdiction of the UNASDG IGO applicable to the procedures carried out within the associated structure.*

*It is also agreed that, in order to implement the defined sustainable development objectives, the UNASDG IGO is authorized to obtain its own banking license from the State, in order to be able to carry out the necessary banking and trade operations, if necessary, independently and without the intervention of third parties, in a controlled manner and in collaboration with the Ministry of Finance.*

*To this end, the Establishment, the Charter and all regulations, functions and objectives set forth therein are fully accepted by the Republic of XXXStateXXX and the Board of Directors of the Intergovernmental Organization UNASDG.*



# UNASDG

THE SENATE

*The instrument of accession, after signature by the Republic of XXXStateXXX, shall be ratified by the State Party and the Senate of the intergovernmental organization UNASDG in accordance with Article 102, Chapter XVI. of the Charter of the United Nations and registered with the Office of the Secretary-General of the United Nations as a diplomatic institution of the State Party.*

*Both Parties will publish the collaboration accordingly on their official websites.*
